RESOLUTION TO RATIFY AGREEMENT WITH OCLC

- WHEREAS, On June 17, 2021, the Board of Trustees of the Cleveland Public Library authorized the Executive Director, CEO or his designees to negotiate with OCLC for the renewal of the Library's OCLC Cataloging and Metadata Subscription and OCLC Worldshare ILL Subscription for the period of July 1, 2021 through June 30, 2022; and
- WHEREAS, The Library and OCLC negotiated a mutually-acceptable renewal to its subscriptions under which changes in CLEVNET membership will result in a proportional change in the fee paid to OCLC based on the number of catalog entries either added or removed from the Library's subscription; and
- WHEREAS, On December 10, 2021, the Library executed an amendment to the Library's OCLC Master Service Agreement and a renewal agreement for the July 1, 2021 through June 30, 2022 term for a total fee of \$276,616.76; and
- WHEREAS, The Executive Director hereby requests that the Board of Library Trustees ratify the agreements entered into with OCLC on December 10, 2021 in the amount of \$276,616.76 for the Library's OCLC Cataloging and Metadata Subscription and OCLC Worldshare ILL Subscription; now therefore be it
- RESOLVED, That the Board of Library Trustees hereby ratifies and approves the agreements entered into with OCLC on December 10, 2021 for the Library's OCLC Cataloging and Metadata Subscription and OCLC Worldshare ILL Subscription for the July 1, 2021 through June 30, 2022 term for a total amount not to exceed \$276,616.76, with \$275,190.82 being charged to the General Fund Account 14140053-53800 (Library Material Control) and \$1,425.94 being charged to the CLEVNET Special Revenue Fund Account 23130103-53800 (Library Material Control).
