RESOLUTION AUTHORIZING AMENDMENT TO AGREEMENT WITH BOSTWICK DESIGN PARTNERSHIP, INC. AND UBIQUITOUS DESIGN LTD FOR DESIGN SERVICES FOR THE WOODLAND BRANCH AND DISTRIBUTION FACILITY

- WHEREAS, On September 26, 2019, the Board of Trustees of the Cleveland Public Library authorized the Executive Director to enter into an agreement with Bostwick Design Partnership, Inc. (in partnership with Ubiquitous Design LTD) ("Bostwick") in an amount not-to-exceed \$363,310 for the design of the renovation of the Woodland branch and \$586,700 for the design of the Central Distribution Facility; and
- WHEREAS, Due to design and other changes requested by the Library as well as unforeseen conditions, this Board authorized five amendments to the agreement with Bostwick, resulting in architect fees totaling \$1,336,753 for both the new Woodland branch and the Central Distribution Facility; and
- WHEREAS, Due to unexpected existing site and building conditions as well as ongoing delivery and coordination issues related to supply chain disruption, the construction schedules for the Woodland branch and Central Distribution Facility have been extended by two months, necessitating an additional two months of construction administration services by Bostwick; and
- WHEREAS, Bostwick has proposed an additional fee of \$21,700 for the work related to the Woodland branch and Central Distribution Facility, which amount will bring Bostwick's architect fees to a total amount not-to-exceed \$1,358,453; and
- WHEREAS, This Board finds that the increase in the fees is fair and reasonable; now therefore be it
- RESOLVED, That the Board of Trustees authorizes the Executive Director, CEO or his designee, to negotiate and execute an amendment to the agreement with Bostwick upon such terms and conditions as are approved by the Library's Director of Legal Affairs, increasing the architect fee by \$21,700 for a total contract amount not-to-exceed \$1,358,453 being charged to the Construction Tax-Exempt fund account 40241105/40279905-55300 (Construction/Improvements).

ASR 09.1 Design Services related to construction schedule extension

Unexpected existing site and building conditions, plus ongoing delivery and coordination issues related to supply chain disruption has caused Gilbane to extend the completion date for both the CDF and the Woodland branch by two months.

We present this request for the corresponding two months of Construction Administration services. The total per month has been calculated based on the average CA phase Architectural services fees over the last 4 months for the CDF and the Woodland Branch projects combined.
