RESOLUTION AUTHORIZING AGREEMENT FOR ANNUAL FIRE SUPPRESSION AND SPRINKLER INSPECTION, TESTING, AND MAINTENANCE

WHEREAS, The Cleveland Public Library conducts annual inspections, testing, and maintenance of its fire suppression and sprinkler systems as required by National Fire Protection Association Standard 25; and

WHEREAS, In order to seek competitive pricing for a new contract, the Library sought price proposals from fourteen vendors for both inspections/testing and maintenance services for a one-year contract with the option to renew for two additional years and received the following three price proposals for inspection and testing services:

WHEREAS, The Library also asked vendors to provide quotes for hourly rates for maintenance services to be provided on an as-needed basis, and the rates provided by S.A. Comunale were lower than those proposed by the other two vendors; and

WHEREAS, The Library Administration has determined that it will receive the best value by selecting S.A. Comunale to provide annual inspection/testing and maintenance services to the Library's fire suppression and sprinkler systems for an annual cost of \$15,772 for inspection and testing or \$47,316 for a three-year term plus maintenance services to be provided on an as-needed basis at the rates set forth in S.A. Comunale's proposal; now therefore be it

RESOLVED, That the Board of Trustees authorizes the Executive Director, CEO, or his designee, to enter into an agreement with S.A. Comunale for annual fire suppression and sprinkler system inspections, testing, and maintenance at the rates set forth in S.A. Comunale's proposal for a one-year term with the option to renew for the agreement for an additional two years, which agreement shall be subject to the approval of the Director of Legal Affairs and which expenditure shall be charged to the General Fund to object code 53340 (Building Maintenance) based on the location.
