RESOLUTION AUTHORIZING PURCHASE OF TRAINING MATERIALS FROM VITALSMARTS FOR CRUCIAL CONVERSATIONS TRAINING

- WHEREAS, The Library recognizes the need to provide effective tools for successful engagement and outcomes in a fast changing and transforming environment; and
- WHEREAS, Crucial Conversations is a course that teaches skills for creating alignment and agreement by fostering open dialogue around high-stakes, emotional, or risky topics—at all levels of an organization; and
- WHEREAS, Crucial Conversations teaches one how to speak and be heard and how to encourage others to do the same, thus setting the platform to allow the surfacing of the best ideas, making the highest-quality decisions, and then acting on the decisions with unity and commitment; and
- WHEREAS, During August 2014, the Library invested in certifying three Administration members in Crucial Conversations Train-the-Trainer Certificate, offered and trade-marked by VitalSmarts; and
- WHEREAS, The Library desires to enable the certified trainers in Library Administration to train all administrators, managers, supervisors, and key supporting staff members as the first group of employees to receive the Crucial Conversations training; and
- WHEREAS, The VitalSmarts' Trainer Agreement for Crucial Conversations stipulates that training material is copyrighted intellectual property of VitalSmarts, and further provides that each person attending a training session must possess an original purchased copy of the printed Crucial Conversations Participant Toolkit, purchased from VitalSmarts or an authorized VitalSmarts vendor; and

- WHEREAS, The Library has received a Sales Quote from VitalSmarts in the amount of \$44,050.00, including shipping and handling, for a total of 200 tool kits; now therefore be it
- RESOLVED, That the Board of Trustees authorizes the Executive Director, CEO or his designee, to purchase 200 tool kits from VitalSmarts at a total cost of \$44,050.00, including shipping and handling, (\$217.00 for each kit; \$650 for shipping and handling) with the expenditure being charged to General Fund Account 11510052-52900 (Other Supplies).
