Operating Budget Timeline



- February 2 Governor John Kasich unveils Executive Version of FY2016-2017 Operating Budget.
- February 10 House introduces House Bill 64, the 2,387 page, Operating Budget text.
 - HB 64 may be split into several separate bills.
- February through March House action on the HB 64.
 - Vote out in the first week of April.
- April through May Senate action on HB 64.
 - Vote in early June.
- June Conference Committee between House and Senate differences.
 - Governor Kasich and Administration play major role as well.
- June 30, 2015 Constitutional deadline for HB 64 to be signed into law.


Budget Overview



- General Revenue Fund (GRF) appropriations of \$35.3 billion in FY 2016 and \$37.0 billion in FY 2017 - total of \$72.3 billion over the biennium.
 - 12.5% increase over estimated FY 2015 spending.
 - 4.8% increase over estimated FY 2016 spending.
- Budget proposal includes a \$375 million increase for the state's Rainy Day Fund.
- The appropriation level for the current biennial FY2014-2015 spending plan is \$61.96 billion.
- Major Principles to craft the Budget:
 - Tax Reform by Cutting Taxes by \$500 Million.
 - Transforming Health Care, Modernizing Medicaid, Strengthening Accountability.
 - Strong Support for K-12 Education and Higher Education Affordability.
 - Helping Ohioans Rise Out of Poverty Through Human Services Innovation.


FY 2016-2017 GRF Recommended Appropriations

Tax Provisions



- Key areas of focus in Gov. Kasich's Operating Budget Tax Reform by Cutting Taxes by \$500 Million.
 - Across-the-board reductions in personal income tax.
 - Increase the Commercial Activity Tax (CAT) from .26% to .32%.
 - Increase sales tax rate by 0.50%.
 - Expand sales tax base to include parking, cable subscriptions, lobbying, consulting and other services.
 - Increase severance and tobacco taxes.
 - Creates Tax Expenditure Review Committee.
