 - Net +1 Republican

House

- **64** Republicans
- **35** Democrats
 - Net +3 Republican

Republicans control all statewide offices and Supreme Court

OHIO REDISTRICTING LEGISLATIVE MAPS

- On January 12, the Supreme Court of Ohio ruled 4-3, that Ohio's new legislative maps were unconstitutional giving the Ohio Redistricting Commission ten days to adopt new district lines
- On January 22, the Ohio Redistricting Commission adopted new four-year legislative maps in a
 party line vote of 5-2, but parties challenging the maps submitted their objections Tuesday,
 asking the court to order the commission to again revise the maps and delay the upcoming
 legislative filing deadline
- In response to the filing deadline uncertainty, lawmakers backed a plan from Secretary of State Frank LaRose to provide temporary authority for the secretary to adjust administrative deadlines between the filing date and Election Day

OHIO REDISTRICTING LEGISLATIVE MAPS

- On February 7, the Ohio Supreme Court again by a 4-3 count rejected the four-year legislative maps, finding they unconstitutionally favor Republicans
- The decision sends the Ohio Redistricting Commission back to the drawing board where they will have to craft new maps by February 17
- This redo means lawmakers will return their focus to legislative maps while also working to meet a February 13 court-mandated deadline to craft new congressional districts

OHIO TAX REVENUES- JANUARY 2022

- State tax revenue continued to surge in January, standing at \$816 million, or 5.5% more than analysts had predicted
- While auto sales tax intake lagged a bit, non-auto sales tax and personal income tax more than made up the difference
- OBM reported that the \$1.153 billion in PIT collections topped estimates for the month by \$188 million, and non-auto taxes came in at \$1.046 billion, which was \$90 million more than anticipated
- The \$2.574 billion in total tax receipts for January bested estimates on which the current state budget is based by \$236 million

SUB HB 126: PROPERTY VALUES

Sub. HB 126 – Property Values (Merrin)

- The bill has undergone substantial changes in the Senate chamber, restricting how school districts and other property taxing entities can challenge property valuations
- New provisions would restrict local taxing districts from initiating complaints before boards of revision unless they own the property in question
- Prohibits school districts from challenging the value of private properties or appealing a BOR's decision but allows them to respond to complaints lodged by other entities
- Bars districts from entering into private pay agreements to settle counter complaints, but doesn't stop them from forging agreements on valuations
- The Senate substitute bill passed out of the chamber in December and is awaiting concurrence from the House otherwise it will head to a conference committee

ARPA OHIO

- Ohio has \$600 million left in state fiscal recovery funds from the first round of the \$2.7 billion received from the federal government in 2021
- Ohio is expected to receive another \$2.7 billion in late spring or early summer 2022
- Ohio has until December 31, 2024 for funds to be obligated
- Unspent funds would be required to be returned to the U.S. Treasury Department
